Toyoshi Fuketa The Nuclear Regulation Authority, Japan

Toyoshi Fuketa graduated from Doctor of Engineering, Tokyo Institute of Technology and received his Ph.D. in Engineering. Dr. Fuketa joined the Japan Atomic Energy Research Institute (JAERI) in 1987 and engaged in nuclear safety research. As NRA Commissioner since September 2012, Dr. Fuketa has dedicated his efforts to the establishment of the New Regulatory Requirements, conformity review processes for nuclear power plants and nuclear fuel cycle facilities, and measures for risk reduction in the decommissioning process of the Fukushima Daiichi NPS. As a leading expert in the field of reactor fuel behavior under accident conditions, Dr. Fuketa took on the position of chairman of OECD/NEA/CSNI and made contribution to international cooperative activities in the area of nuclear safety research. Dr. Fuketa has been NRA Chairman since September 2017.

William D. Magwood, IV Director-General. OECD Nuclear Energy Agency (NEA)

William D. Magwood IV is the NEA Director-General since 2014. Prior, he served as Commissioner appointed by the US President and confirmed by the Senate to the US NRC. 2005-2010, he provided independent strategic and policy advice on energy, environmental and technology policy issues. 1998-2005, Mr. Magwood was Director of Nuclear Energy at the US DoE, where he launched several important initiatives including GIF. He began his career working as a scientist for Westinghouse and Edison Electric Institute. Mr. Magwood holds Bachelor's degrees in Physics and English from Carnegie Mellon University and a Master of Fine Arts from University of Pittsburgh.

Hiroko Kondo has been an independent consultant since 2015 after working as a managing consultant at Alcoa Asia and IBM Japan (formerly PwC, IBCS) and a senior principal at Accenture. She has been engaged in business consulting for the infrastructure industry for over 20 years. She is the author of "Exploring the Evolution of Regulation from the Process of Reform" (2019).

Noriko Endo

Project Professor, Keio University Global Research Institute

Noriko Endo completed the doctorate program of Energy Science at the Graduate School of Energy Science, Kyoto University to earn her Ph.D. in energy science. She specializes in energy policy, risk and security governance, as well as economic security.

She was appointed her current position to research and educate, following a career as an assistant editor-in-chief for an economic magazine. She was engaged in the 2017 Abe Fellowship (Researcher). She published her book, "Study of Japan's Nuclear Damage Compensation Scheme—Reviewing Tokyo Electric Power Company's Fukushima Daiichi Nuclear Power Station Accident" (Iwanami Shoten, Publishers) and went on to receive the 14th Osaragi Jiro Press Award for her work. She also serves as a member of the following governmental committees: Fiscal System Council; Nuclear Energy Subcommittee, Electricity and Gas Industry Committee, Advisory Committee for Natural Resources and Energy.

Toshiyuki Oshima completed the master's program at Hokkaido University Graduate School in 1993 and joined the Science and Technology Agency.
